Their **indexes** are believed to give much greater facility in consultation **than those in the old edition**.

We find, by **comparison** of the original edition of the Reports with the records of the Court at Washington, that, in many **important cases**, the **head-notes** were **written by the Judges**. The same is true of the **statements of fact**, in a majority of cases, these being generally embraced in the **opinion** of the Court. Such, of course, **are printed** by us *verbatim*, as found in the **records**, in their proper places, with due credit. These we conscientiously preserve, as being the only head-notes and statements proper to be used with their respective opinions. Our **additional editorial work**, therefore, from the 58th volume on, beyond correction of unauthorized changes and errors, consists **largely** in the **preparation** of the **Arguments of Counsel** and improved indexes, references, notes and tables. This is done exclusively from the **records**, and we aim to give extra value to this work **by giving the authorities cited by counsel to each point**.

*N. B.* Our **editorial additions**, foot-notes, tables of cases, citations, *etc.*, will be **continued**, making and remaining the **ONLY COMPLETE, CORRECT, UNIFORM, UNCONDENSED, ANNOTATED EDITION EXTANT, OR PROPOSED**.
